18/12 **MINUTES OF THE MEETING HELD ON 31 JANUARY 2012**

The minutes of the meeting held on 27 March 2012 were agreed and signed as a correct record.

19/12 **CORRESPONDENCE RECEIVED**

It had been confirmed that Borough Council had now ordered the installation of the "Teen Lighting" at Canterbury Road from *eon* networks and that it would be operative within the next few weeks. The system would be activated by sensors and have a cut-off time of 10 pm.

20/12 **EXISTING PROJECTS – PROGRESS REPORT**

The plants for the planter maintained at Canterbury Road by the Youth Council would be ready after half term. Councillors Horton, Pastre, Higgs and Parker volunteered to do the planting.

There was a brief discussion regarding the Summer Fayre taking place on Monday 4 June. Further to the previous ideas put forward it was suggested that the Youth Council could have stalls selling plants and lollypops.

21/12 **FUTURE PROJECTS**

The Chairman reported on his trip to Watford to see one of Proludic's Sports Legacy Zones in operation. This included climbing equipment, a BMX track, cable run, basketball court, outdoor gym and trim trail.

Mr Dickerson from Proludic showed Members a video of the interactive customer designed sports and play equipment. This enables people to download information on their smart phones using a QR Code. This enables them to access instructions, challenges and coaching programmes at basic, intermediate and advanced levels. As such the equipment can be used as just play equipment whilst the coaching takes it to another level. The ethos behind the equipment was that of “Helping communities to a lasting legacy through play, sport and fitness”. The website is [www.proludic.co.uk](http://www.proludic.co.uk)

It was explained that Proludic would assist with the bids for funding having completed the initial design and a “People – Places – Play funding document was handed out to the Members. In this respect it was pointed out that there were several partner organisations such as the schools, Trent & Dove and Burton Albion together with a history of planning to meet the need. This had been well documented in the Burton Mail article of 29 March 2012.

Proludic also explained that after the site was opened by a local Olympian they were willing to support the scheme over the longer term including a 3 year maintenance guarantee.

It was suggested that the Youth Council Members should be involved in the bidding process.

#### 22/12 **FINANCIAL REPORT**

It was reported that the Youth Council currently has existing funds of £5,295.91 although a further contribution of £2,000 was likely to be forthcoming from the Parish Council.
