40/17 **COUNTY COUNCILLORS' REPORT**

41/17 **BOROUGH COUNCILLOR'S REPORT**

Councillor Fletcher had nothing new to report.

42/17 **NEIGHBOURHOOD RESOURCE CENTRE CO-ORDINATORS REPORT**

The co-ordinator reported that the CAB were still very busy helping people with benefit forms. The Clerk reported that they were happy to continue with the service after 1st April 2017 based on the current arrangements. He also agreed to contact them to explore the possibility of extending the hours to meet the current needs of parishioners.

There was a brief discussion regarding the external lighting and the guttering at the Centre. It was agreed that a future meeting be set up with Trent & Dove to discuss the future maintenance of the Resource Centre.

43/17 **NEIGHBOURHOOD PLAN**

The Clerk reported that he had now submitted the updated Neighbourhood Plan along with the supporting Basic Conditions Statement and the Consultation Statement to the Borough Council. He is now awaiting their response before they undertake their own Regulation 16 consultation prior to going before a Planning Inspector by around July 2017.

44/17 **NEWSLETTER/WEBSITE/PUBLICITY**

The Information and Publicity Committee report on communication and the use of social media when completed will be circulated and discussed at the following meeting along with draft policy and procedures.

The Clerk advised of the need for newsletter articles by around the first week of May 2017 for the Spring Edition in order to advertise the Summer Fayre on May 29th 2017.

45/17 **REVIEW OF PLANTING/GROUNDS MAINTENANCE**

Following the meeting with Idverde to discuss an extension to the existing grounds maintenance contract Winshill Bloomers were still waiting for them to come back with details of the quote. It was anticipated that the annual work around the Centre and the Peace Wood would cost around £2,000 more, but this would still be cost effective when considering the cost of the previous contractor for work at the Centre.

The judging for Heart of England in Bloom will take place on the morning of 11th July 2017 with the date for Winshill in Bloom still to be determined.

Reference was also made to entering the Peace Wood and Wheatley Lane Recreation Ground into the RHS's Parks & Open Spaces competition, particularly as the acers have now been planted at the Peace Wood and the planning for the memorial garden is progressing.

The Chairman mentioned that he had been asked by several residents to raise the issue of the money being spent on the so called “Dead Wood”. In response, the members pointed out that they had received numerous comments of support for the highly-commended “Peace Wood”. Further, the project had been almost entirely funded by external grant aid with only a small proportion coming from the Parish Precept. Also, the planned permanent memorial will be largely funded by public donations. Whilst it is accepted there may be those who do not approve of the scheme the Parish Council along with many of the residents consider it is important to remember those from Winshill who had lost their lives in the service of their country in a tangible manner that people can relate to.

47/17 **APPLICATIONS FOR FUNDING**

Members considered application made by Winshill Allotment Association for annual running costs and maintenance in line with the previously agreed formulae - Minute 56/16 refers. A request from Shoutout was referred to the Grants Committee for further consideration.
