40/10 REVIEW OF PLANTING/GROUNDS MAINTENANCE

Progress on the planting scheme was reported.

The existing flower beds had been enlarged and poles for hanging baskets would be erected opposite the shops and outside the Resource Centre.

Following the newsletter article regarding "adopt a tub" most of these had now been taken up.

Good reports were already being received about the new Lengthsman. It was suggested that a board could be put in the Resource Centre for people to suggested tasks for the Lengthsman.

Contribution of £5,735.50 and £500 had been received from the Borough Council towards extending the flower beds/planting and the hire of attractions at the Parish Fayre.
