#### Introduction

At Winshill Parish Council we are, I believe, justifiably proud of our achievements over the nineteen years of our existence.

From the outset we aimed: -

- To make Winshill a place of which we can all be proud.
- To make Winshill a place where all who live there feel they have a stake in their community.
- To make Winshill a place where people feel their opinions are valued.
- To represent the people of Winshill and put their hopes and aspirations at the top of our agenda.

It was not long before we realised that to further those aims we needed to consult with the people to ascertain their desires. It did, however, seem reasonable for us to assume they would want :-

- To be able to walk around safely and free from intimidation.
- To keep the area free from over-development and ensure that such developments as there are, are in keeping with the surroundings.
- To ensure Winshill has a clean, litter free environment.
- To ensure there will be adequate provision of areas where children can play safely.
- To see our parks and open spaces protected and improved in a way which satisfies the needs of the majority.

We produced our first Parish plan in 2009 following consultations in 2008. Our second Parish Plan was produced in 2013. In both cases we produced an Action Plan to guide our future activities.

I believe that as a result of our actions Winshill is a very different place from what it was in 2003.

This document contains a lot of interesting facts and information about Winshill including its history. By far the most important section, however, is the Action Plan which sets out what we intend to do over the next three or four years based on the results of our consultation. We hope that you will keep the plan and judge us against those stated intentions.




## An outline of Winshill

Winshill lies in the borough of East Staffordshire in the County of Stafford where it borders with Derbyshire. It is on the East side of the River Trent and is watched over by the Water Tower on Waterloo Clump (so named after Wellington's victory over the French) and St. Mark's Church.

The Water Tower is Burton's most famous landmark and it can be seen from miles away from whichever direction you approach Burton upon Trent.

Winshill was parished in 2003 and elected its first parish council that year.







## A brief history of Winshill

The name Winshill has its origin in Old English and means Wine's Hill. There was a settlement here in the late 11th Century when William 1st installed privileged tenants at Winshill. By this time there was a corn mill on the Winshill bank of the River Trent, and in the 14th Century a fulling mill, which became a cotton mill in the late 18th Century was built on an island nearby.

By the end of the 18th Century the village was grouped around a green on the east side of the hill. The medieval Burton bridge crossed into Winshill at its east end, and the road to Ashby-de-la-Zouch then followed a line along Bearwood Hill Road and High Bank Road. A tollgate was placed near the foot of Bearwood Hill Road when it became a turnpike road in 1753. Ashby Road was put onto a more direct line in the later 1830's and the tollgate was then near Moat Bank.





Winshill was popular in the 19th Century with prosperous citizens of Burton who built large houses like Bladon House, The Woodlands, Highfield House and Moat Bank on the higher ground overlooking the town. At the same time rows of houses were being built for brewery workers on Bearwood Hill Road, Church Hill Street, North Street, East Street and West Street.

#### Winshill Parish Council 2003 to 2022

Winshill Parish Council was formed in 2003 following the Borough Council's decision to parish Burton. At the time this document is created the Parish Council will have been in existence for just 19 years and yet in that short time it has achieved so much.

- Three massive consultations that helped to produce our three Parish Plans.
- Production of a Neighbourhood Plan to help us have some measure of control over planning issues, and Production of an Emergency Plan to help us through difficult times.
- 17 Shrub beds created and maintained in addition to those at the Winshill Neighbourhood Resource Centre (WNRC), 27 Tubs planted by community Groups (Adopt a tub), 7 Barrier Baskets on Ashby Rd opposite Bretby Lane, 12 Hanging Baskets on Bearwood Hill Road, 6 Hanging baskets above the "new" shops in Hawfield Lane and 6 up the pole planters outside Buckingham Court and 2 outside the WNRC.
- Gardening workshops for schools and local groups, including raised allotment beds at each of the 4 schools.
- Annual Parish Fayres.
- WNRC providing a venue for local groups and volunteers.
- Allotment beds at the WNRC, with Community orchard adjacent.
- Orchard at Tower View school.
- Financial support to Bearwood and Wheatley Lane allotment Associations.
- Bench Seats on Bearwood Hill, Wheatley Lane Rec, Melbourne Avenue and the Peace Wood.
- Created the Coltman VC Peace Wood.
- Helped with Grey to Green Projects on Little Empire Road, Newton Road Park,
   Wyndham Crescent and the WNRC.

- Best Floral Feature competitions held for Commercial organisations, Non -Commercial Organisations, Individuals and Adopt-a- Tub; with a presentation evening each September.
- Won 6 successive Gold medals in RHS Heart of England in Bloom, Finalists in RHS Britain In Bloom 2019.
- Gold Award for the Peace Wood in H of E in Bloom Open Spaces category 2018, 2019 and 2021.
- Top Awards on four occasions for the WNRC in RHS It's Your Neighbourhood category.
- Supported Tower View School to obtain three Gold awards in School' section of H of E in Bloom.
- The only Youth Parish Council in Staffordshire.
- Gym equipment on Canterbury Road Park, Recreational Equipment on Wheatley Lane Recreation ground.
- Maintenance Plan for the Dales and Newton Road Park.
- Grants to various organisations.
- Winshill Walks booklets.
- Healthy eating cookery leaflets.
- Wild Flower Meadows.
- Displays of WW1 and the men who served.
- A memorial in the Peace wood to those from Winshill who served in conflicts in the last century.
- A memorial tree planted next to the Peace Wood for those in Winshill who died of Covid 19 or lost loved ones during the pandemic.
- Speed indicator display (SID) signs on Newton Road.
- Defibrillator at the WNRC.
- Community Speed Watch operating in Winshill.

## Introduction to the Parish plan

This is the third Parish Plan produced for Winshill. It continues and extends the work undertaken following the two previous plans.

## **The Planning Framework**

The Local Planning framework has changed considerably over the years since the formation of Winshill Parish Council. There are three different types of local plan that can directly affect life in Winshill. They have confusingly similar titles:

- 1. The "Local Plan' by the local planning authority East Staffs Borough Council's local plan is used as a guide to judging planning issues and includes Winshill.
- 2. "Winshill Neighbourhood Plan" is a planning document that aims to enhance and protect the built and natural environments. It has policies on housing provision, building conversion and sub-division for residential development and many more. For more detail consult the Winshill Neighbourhood Plan 2015. The Neighbourhood Plan can influence the Local Plan.
- 3. "Winshill Parish Plan" Winshill Parish Council have produced two previous Parish Plans This is the third.

## What is a Parish plan?

A Parish Plan is a statement from the Parish Council outlining its 'vision' for the future of the Parish based on the views of parishioners following wide ranging consultation. It will highlight: -

- What is important to people in the parish.
- How the future of the parish can be safeguarded.
- What facilities the parish needs for the future.
- What problems there are that need to be tackled.
- What action needs to be taken to tackle issues and who should be responsible for ensuring the actions are undertaken and what partners will be involved.

## How useful will a Parish plan be?

Parish Plans do not have any statutory powers. However they often influence borough/county councils when they are making decision. They can influence inspectors during public enquiries or other disputes. They should influence Borough and County councils when they draw up future policy. But, the main thing is, they help members of the community to focus on key issues affecting them and help drive projects forward to sort the issues out.

#### About the consultation

An online questionnaire was published on Facebook the Parish Council web page inviting people to take part in a consultation exercise to help shape future actions for the benefit of the people of Winshill.

A paper copy of the questionnaire was made available for those who preferred one. Depending on the questions people were asked either to write or grade their answers.

#### The questions were: -


- What is your postcode?
- What is your age?
- Tell us what you like most about Winshill.
- What do you like least about Winshill?
- If you were able to improve two things about Winshill, what would they be?
- How often do you participate in activities (sport, leisure, community initiatives etc.) in Winshill?
- If you do not participate in activities in Winshill, please tell us why?
- What types of activities would you participate in if they were available in Winshill?
- How strong is the sense of community in Winshill?
- Would you like to see any changes made to Winshill Parish Fayre such as the date, additional activities etc.?
- How effective do you think support for young people is in Winshill?
- Do you feel that elderly residents are supported in Winshill?
- How often do you visit the public parks in Winshill?
- How satisfied are you with the parks in Winshill?


- If you visit any of the public parks in Winshill, what improvements would you like to see?
- How would you rate the planting in and around Winshill?
- Overall, how clean is Winshill?
- Overall, how safe do you feel in Winshill?
- Do you think speeding traffic is a problem in Winshill?
- Do you have issues with parking where you live?
- Do you use the bus?
- How important do you think it is that Winshill plays its part in tackling climate change?
- How proud are you to live in Winshill?
- Do you have any other comments, questions, or concerns that would be helpful when producing the Plan or is there anything that we haven't mentioned which concerns you?

The responses were analysed using "Survey Monkey" and an Action Plan was created to enable us to plan future actions for the development of Winshill.


#### What we learned from the consultation







When asked what improvements they would like to see in Winshill, 243 ideas were put forward. The most frequently occurring items concerned street tidiness and litter, reducing anti-social behaviour and drug use, and greater police presence. There was also strong support for activities for young people and more amenities in green spaces.



Many people listed location and environmental factors in their list of likes. The above graph is a break down of the responses.

# Introduction to the action plan

The Action plan is divided into five sections

- 1. Community.
- 2. Environment.
- 3. Traffic and Road Safety.
- 4. Leisure and Wellbeing.
- 5. Crime and Anti-Social Behaviour.

For each section the plan shows a series of visions and the actions needed to achieve them.

Each action shows the partners we will work with to achieve it, the priority given to the action and the timescale for its implementation.

- Short term timescales mean the vision would be expected to be achieved in 0 to 2 years
- Medium term in 2 to 4 years
- Long term over four years.
- Where the plan shows "ongoing" in the timescale column, this means that the action will be continuous, possibly over a number of years.

It should be pointed out that, to achieve the community's visions, most of the actions will require the help and co-operation of other agencies and may need some form of financial commitment that may impinge on the Parish Precept.

### The functions of statutory bodies

Many people confuse the function of the differing statutory bodies when trying to obtain advice, seek assistance or make a complaint. Most organisations will refer you to the appropriate bodies but, to help you, we have listed the various statutory bodies and major organisations together with a brief description of their functions.

## **Types of Council**

In Winshill you will be served by three different types of council; Staffordshire County Council, East Staffs Borough Council and Winshill Parish Council

**Staffordshire County Council** is responsible for services across the whole of a county, like:

- Education
- Transport
- Planning
- fire and public safety
- social care
- libraries
- waste management (though collection of waste is devolved to the borough council)
- trading standards

**East staffs Borough Council** covers a smaller area than the county council. It is responsible for services like:

- waste collection & recycling
- Council Tax collections
- planning applications

**Winshill Parish Council** operates at a lower level than the other two. Councillors are elected and can help on a number of local issues, like providing:

- allotments
- public clocks
- bus shelters
- community centres
- play areas and play equipment
- grants to help local organisations
- consultation on neighbourhood plans

#### **Decision making**

The full council (a meeting of all council members) is responsible for all decisions. But in practice, most of the work is given to smaller groups of councillors or council officers (paid staff).

Every council must publish:

- details of when key decisions will be taken
- agendas of meetings at least 5 working days beforehand
- minutes of meetings showing the decisions that were made

You can view council meeting agendas, minutes and reports on the county, borough and parish council websites.

You can also attend most council meetings.
